History of Apex Efficiency Solutions

Apex Efficiency Solutions was founded in 2012 as a result of our ownership team growing tired of the way Energy Service Companies delivered renewable energy and energy efficiency projects. Our new business model has changed the way our projects are developed, marketed, and delivered.

Apex Efficiency Solutions was incorporated as a Minnesota Public Benefit Corporation on January 2, 2015.

Apex's goal is to improve the environment by upgrading the energy efficiency of buildings, reducing both the carbon emissions and pollution that is released to the environment from these facilities. The company also serves the less fortunate by helping alleviate poverty, improving educational opportunities, providing housing and addressing the exploitation of children.

Pursuit of our Mission

Regarding the period covered by this report, January 1, 2018 to December 31, 2018, Apex Efficiency Solutions pursued the specific benefit purpose stated in its articles of incorporation in the following ways.

Apex Efficiency Solutions works with commercial and industrial clients to improve their energy efficiency. We do that by identifying potential energy saving opportunities, and then working with them to quantify the costs and savings associated with those opportunities, ultimately implementing them and then providing measurement and verification of the actual savings achieved.

We believe that Apex Efficiency Solutions was successful in achieving the goals of our specific benefit purpose in the following ways.

In the projects completed with our clients in 2018, we will save them an estimated 361,867 kWh of electricity. These projects were completed at various times throughout the year. When we add those projects to the past projects our company has completed for our clients, the total energy savings are an estimated 10,985,255 kWh of electricity. According to the EPA, this equates to over 7,768 metric tons of CO2 reduction. Additionally, in the projects completed with our clients in 2018, we will also be able to save them an estimated 827,940 kWh in renewable energy (Solar). According to the EPA, this equates to an additional 585 metric tons of CO2 reduction.

Apex Foundation:

As one of the first Specific Benefit Corporations in Minnesota, we strive to alleviate poverty and homelessness, as well as improve education opportunities and address the exploitation of children. We tithe corporate profits into the Apex Foundation to assist with this mission.

It is our goal at Apex to continuously improve the world through the implementation of fiscally-responsible and environmentally-friendly projects. Plus, we actively work to improve the community around us and abroad by dedicating a portion of each year's profits to these causes. Half of Apex

Foundation's assets are used to help in the local community. The other half of the assets are used globally to help fight poverty and injustice.

In January of 2018, Apex sent one employee to Haiti. On that trip work was done on the Medical Center that is being built in order to stabilize the foundation and finish its porch. There was also more work that was done on the sewing building where local Haitians are trained to become tailors and seamstresses.

In April Apex sent two employees to Haiti. During that trip the Medical Center was painted, a new well for the community was brought on line, and a team hiked up into the mountains to build some desks for the mountain school that the Apex office supports.
