Via Vita, SBC is a specific benefit corporation that has elected to develop a web application and related programs that will guide teenagers and young adults by helping them navigate the difficult path to careers that are rewarding and meaningful. The corporation began development of the software in 2019 and completed most of the development by April of 2020. Upon completion of the development phase, the software was put through a testing phase by more than 100 students in 2020. Enhancements identified through the testing phase were added to the application during 2021 through 2023.
