Our public benefit is (1) replacing our packaging with compostable packaging. (2) creating condensed body care products that do not need to be bottled. (3) plan on donating 3% of profit to Clean Water Action.

- (i) chosen the third-party standard designated pursuant to clause (2), item (i);

Nora Schaper and Jay Schaper are the board of directors. Jay being the one who filed the organization papers. It is my wife, Nora, and myself, Jay, who decided on B Lab certification because we saw many brands with their certification logo and they have many excellent resources online for us to use. They have a straight forward, although lengthy, process for certification that we found helpful. Their Url is https://www.bcorporation.net

Nora and I determined they are a non profit independent (meaning they are not part of Bodylish). That is verified on their website.

- (ii) with reference to that third-party standard, describe:
- (A) how the corporation has pursued general public benefit;

Our business operations have contributed to a positive impact on the local environment. And our product packaging has made steps toward a net material positive impact by:

- Having a 100% recycling program for all our materials used at bodylish. All glass and plastic bottles that our COGS are received in are sent to the recycler for re-use when emptied.
- We re-use all the packaging material received with these COGS in our own out going shipments.
- We have verified that our suppliers do not use polluting packing peanuts or plastic air bags in their shipping of products to us thereby eliminating the plastic and polluting products like these are not passed through us onto the landfill. We pre screen them before we do business. It's part of our Good Manufacturing Processes certification we received in June of 2015.
- Also verified that are Shea Butter used in a lot of out products is certified as Fair Trade with the african nation of Ghana.
- Our business has verified and possesses the paperwork that our Palm oil is from a sustainable source and portion of proceeds used to to the environmental protection of Orangutans. This group is called Sumatran Orangutan Conservation Program SOCP of which our supplier of Palm oil (Columbus Oils) is a member of this organization.
- We have committed to donating 1% of our profit to Clean Water Action. This helps in the clean water action commitments to improve our environmental and social The check will be written in April of 2016 and shared publicly on our Facebook page.
- We switched our product packaging to be 100% compostable. It is made from sustainable wood. They are cello bags and we use them for our bath bomb line of products.
- We established a new plan of eliminating the use of any plastic and glass in our product packaging and replacing it with compostable packaging. This involves changing our product

line so that it is a solid bar line of products and does not include products that need to be bottled.

 We have committed to B Lab and their third party assessment program. This is teaching us lot about helping to provide strong communities by screening our vendors and suppliers for paying a living wage and serving under served sections of our community.

- Bodylish has pursued GPB by committing to donating 1% of our profit to Clean Water Action.
 The check will be written in April of 2016 and shared publicly on our Facebook page.
- We also have a recycle program where all our incoming containers of COGS are recycles and we re-use all the packaging material received in our own out going packaging.
- We switched our product packaging to be 100% compostable. It is made from sustainable wood. They are cello bags and we use them for our bath bomb line of products.
