Pursuant to Minn. Stat. 304A.301, the undersigned hereby swears to the veracity of the information herein, and submits the following as its Annual Benefit Report for 2016:

- 1. Corporate Name: ELEMENT BOXING AND FITNESS, SBC (the "Corporation")
- 2. The public benefit corporation's board of directors has reviewed and approved this report.
- B. Pursuant-to-Minn. Stat: 304A.301, subd. 2, the annual benefit report is based on the Corporation's stated public benefit as listed in Article 2 of its Articles of Incorporation, which is: ("To create, and provide access to, exercise programs to keep youth and adults in the Saint Paul community active") (the "Benefit"). The narrative description of the Corporation's activities is as follows:
  - a. The Corporation pursued and created the Benefit by [Creating and implementing a Competitive Boxing training class for the community, this class started 2 months ago and has been a consistently popular class for youth and adults who are advancing in their technique of boxing. We have an average of 100 participants on a weekly that come to learn the art of boxing and experience training like a professional. This class is year round and we expect higher numbers in the summer time.

In December 2016, Element Boxing and Fitness, SBC developed and started a gym-class for a local alternative high school of more than 50 students. Students walk a quarter-mile from school at 2:00pm to participate in gym activities at our gym facility. This class in popular with students and teachers, due to the fact they don't have a gym at their facility. This class with last through June when school ends but will start back up in fall of 2017.

January 2017, Element started working with Bellum Brazilian Jujitsu a Marital Arts form that offers programs for both children and adults. Since opening the programs have slowly increased enrollment from 0-15 students currently. We expect numbers to continue to increase through this year as we are still building awareness of the program.
