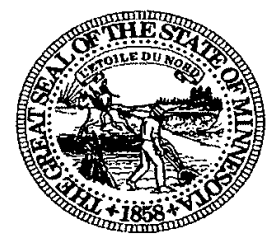

Renewal Venture Commons GBC (RVC) was formed in late December 2016. Since incorporating, the company has been actively working to identify and complete projects which will promote human health and well-being. By combining impact investment capital with our own resources, capabilities, and sweat equity, we will build sustainable businesses in the health and wellness space to improve the health outcomes of local communities, thus pursuing a general public benefit. As yet, no projects have commenced.
This is the first Report the Board has filed. The third-party standard chosen by RVC is B Labs, a non-profit organization with main offices at 155 East Lancaster Avenue, 2nd Floor, Wayne, PA 19087. RVC is in process of obtaining B-corporation certification and expects to be completed by May 31, 2017. We chose this third-party standard based on research and determination that B Labs is a well-known non-profit organization whose standards are commonly used by other general benefit corporations.
