Hair, Head + Heart was incorporated on June 23, 2016 as a General Benefit Corporation under Minnesota's Public Benefit Corporation Act 302A Pursuant to Section 304A.101 of the Act, general public benefit purpose as stated in its Articles of Incorporation has:

- created awareness in the community for a variety of issues and resources
- embraced and showcased people and causes from an extremely diverse pool of interviewees
- practiced inclusive media methods, standards and stories to a traditionally conservative talk radio genre

The startup: The following is a description of how we believe we succeeded in achieving the goals of our specific public benefit purpose.

• We have presented over 35 shows inside and outside of the studio. At no cost, listeners can download the wellness radio app, request podcasts on demand and tune in to our Saturday, 3pm weekly time slot.

Some of the presenters & topics on Hair, Head + Heart included: A West African woman who survived human trafficking and now owns a n a non-profit, a Black gentleman who patented exercise equipment, a Chinese blind female who is an international traveler, a few Caucasians from the Twin Cities Dads group, an African American female who is presenting legislation for Minnesota infants to receive screening for the G6pd enzyme deficiency, a 50th year commemoration of the Black Panther Party, trends, politics and more to help people know better, do better and be better.

- We share an abundance of community information and sources with listeners like: business funding for veterans, earth/sustainability workshops, resources for the blind, miscellaneous U of M studies, political action and encouragement beyond the basics.
- I have participated in a variety of trainings to become a better radio journalist, one was in Murfreesboro Tennessee. The entity was reviewed by and accepted into the MNUCP and other directories.

Challenges:

- Nothing really prevented us from achieving our specific public benefit purpose. There was a learning curve and acceptance that the primary/lead would need to sell advertising and or find sponsors if the organization was to grow beyond being a boot strap venture.
- There has been positive response to requests for sponsors/advertising resulting in sales and voice over work, however, the entity does not yet pay for itself.
- Demographics, ratings and numbers have not been calculated and this creates a hurdle with putting together an appropriate marketing plan.
- The time commitment needed to become a subject matter expert every seven days creates situations that may be better served by creating an internship or bring in a part time worker of some type

in 2016:

Our board of directors used the following process to choose our enumerated third-party standard:

- Owner initiation with established membership and participation of balancing

We list with juried directories (such as the Minnesota Unified Certification Program. (MNUCP) They represent the Minnesota Department of Transportation, Metro Airports Commission, Met Council and more. They certified this entity February 29, 2017 after a vigorous review, visitation from a MNUCP representative and panel reviews and recommendations.

We partner with Salem Media Group which has 2,700 media affiliates and 112 radio stations across the country. They help set perimeters with which to operate. They have 73 stations in the nation's top 25 markets and 25 in the top 10. Beyond the contracted hour, the popularity of the show has gained more time slots each week at no aditioanl cost to the entity.
