Hanadi sbc was incorporated on November 18, 2017 as a specific benefit corporation that pursues the following purpose: to educate people about Islam in order to establish a better understanding of the Muslim population in America and help eliminate the well-endorsed hate through public speaking, consulting and media intervention for a better portrayal of Muslims in the mainstream media. Here's an progress report on the covered period:

1) From inception until the end of 2017 we have been able to:

(i) Lead two sessions with The Study group in Wayzata in "Islamic legislation" and "women in Islam", which 40 women from prominent families attended. Hanadi, the president, has also been invited to the Society for Human Resource Management (SHRM), a leading Human Resource organization, at their Diversity & Inclusion conference and exposition in San Francisco and delivered a keynote speech on "Demystifying Islam and Muslims". The session was attended by 70 HR professionals who rated the information and overall performance and content as outstanding.

Another presentation was delivered at Mount Calvary Lutheran Church and was attended by around 50 congregation members on the "Muslim experience in America". The event was meant to build bridges between the Muslim community and the larger community with an open conversation.

At the end of 2017, Gail Rosenblum from the Star Tribune rounded up her end-of-year column with calling Hanadi Chehabeddine an "Everyday Hero" and mentioning the launch of Hanadi sbc and the work I am doing as a public speaker.

(ii) Despite how young this company is, Hanadi sbc has been able to kick-start important activities and events dispelling myths about Islam and Muslims, creating bonds and educating people about one of the world's oldest religion through speaking to the above mentioned communities and engaging in enriching discussions. The total number of

audience reached is around 160 people. Add to that the impact of a leading publication such as the Star Tribune mentioning a Muslim woman as a source of inspiration to all Americans, challenging with that the negative portrayal of Muslims in mainstream media.

- (iii) Marketing my services and spreading the word about my work has been the biggest challenge from accomplishing more significant events. The lack of a marketing budget is one obstacle that needs to be addressed in the future.
