(A) how the corporation has pursued general public benefit;

We pursue the general public benefit by the transparency of our governance structures, volunteering in the community, giving scholarships to those in need, and two-way engagement with customers. That is, we seek and respond to their feedback and incorporate their ideas. We also donate a portion of our proceeds to non-profit organizations in our community. We are a very small organization, with no full time employees other than the two owners; thus we cannot have as much impact in terms of ESOP type programs for employees, or other pro-workers structures and policies. With regard to environment, we are a services business, so we do not source or produce tangible goods where our choice of vendors might impact our environment. We do use solar power in our offices.

Here is a topline summary of our performance in terms of B-Lab's five categories of general impact. As you can see, we had a big jump in performance between our first and second year in existence. This year, it looked like we fell back just a little. Two areas increased: transparency of governance and community involvement, while others decreased. In actuality, we did not do less in those areas, rather B-Lab added more metrics in areas that we don't currently measure.

We do not specifically measure the degree to which we have benefitted the public. We are still in a start-up phase of our operations, and hope to be able to do that in succeeding years.

For us the biggest hindrance this year was the situation caused by the advent of COVID 19. This severely curtailed our plans, and forced us to take the programs we were already in the midst of offering online. We might have had an increase in the metrics measured by B Lab had we been able to continue on with our early 2020 plans. As it was we were glad to do as well as we did.


