Minnesota Public Benefit Corporation / Annual Benefit Report Pura Vida Elite Training SBC

Pura Vida Elite Training SBC is a public benefit corporation whose purpose is to "generally improve the athleticism of economically, socially and racially diverse youths, ages 6-16; teaching leadership, sportsmanship and healthy lifestyles and elevating soccer skills through professional coaching and an appreciation of the worldwide, positive impact of soccer on domestic and international communities."

Pura Vida Elite Training SBC, (Pura Vida), was organized on August 11, 2020. Since founding Pura Vida, we have developed the depth and breadth of our soccer programming, grown our coaching staff and expanded our player base at a steady pace. Our owners, coaches and players are racially, economically, culturally and gender diverse.

Pura Vida has grown its player From a few dozen players at inception, , we had grown to 200 players by Dec 31, 2020, and currently have 264 registered players. Our players come from nearly every suburban and urban neighborhood of the Twin Cities. Approximately 30% of our players have diverse international origins, including Pakistan, Somalia, Ecuador, Korea, China, Mexico, Costa Rica, Kenya and Egypt among others. We are creating a rich community of players and families, coming together to celebrate the game of soccer and dedicate themselves to the pursuit of playing it at the highest possible level.

Pura Vida Elite Training has grown its coaching staff from one coach to eleven. We have engaged professionals in the fields of Elite Sports Performance and Sports Psychology to consult in the formation of our curriculum. Our coaching staff, like our players, is culturally, racially and economically diverse. Daniel Vargas, co-founder, co-owner and head coach is Latino. 60% of our coaching staff is Latino. 10% is East African. 40% of our coaching staff is female. 60% of our coaching staff has played professionally. 80% has played at the college level. Through their collective diversity and high-level of experience, both as players and coaches, Pura Vida's coaching staff is uniquely qualified to mentor our diverse player base, to inspire them, to guide them in the formation of leadership skills.

Pura Vida Elite experienced nearly two months of shut downs, while abiding by COVID-19 safety measures and MN Executive orders. Despite these disruptions, we have successfully resumed a training schedule of 150-250 player/hours per week. As we resumed training safely at the close of 2020, we have been able to invest human and financial capital to build to expand upon our programming and to fulfill our mission of offering greater community access and high-level training at a lower cost.

Pura Vida Elite Training SBC has just signed lease in 2021 for a 30,000 square foot commercial warehouse space in Brooklyn Park. We are excited to open the doors of Casa Pura Vida on April 5th, 2020 and welcome our community.
