Annual Benefit Report Other Half Processing, SBC

A Minnesota Specific Public Benefit Corporation

Other Half Processing was incorporated on July 16, 2017 as a Specific Benefit Corporation under Minnesota's Public Benefit Corporation Act (the "Act"). Pursuant to Section 304A.101 of the Act, Other Half Processing's specific public benefit purpose as stated in its Articles of Incorporation is:

To create high value and high-quality products in ways that are ethical and respectful to the animal, and support regenerative farmers, ranchers and agricultural systems.

Throughout this report, Other Half Processing will be referred to as OHP or may refer to itself as "we", or "our" or "us."

OTHER HALF PROCESSING SBC

Other Half Processing SBC (OHP) partners with US farmers and ranchers to source and market identity-preserved byproducts from the "other half" of US livestock raised under regenerative and organic systems.

The following is a description of how we believe we succeeded in achieving the goals of our specific public benefit purpose.

OHP had success in 2020 building demand for traceable and verified regenerative hides for leather, with Timberland® as a key customer and market partner. The first boots made from OHP sourced leather were produced and sold, and there is growing demand and use of regenerative leather in apparel and other industries. OHP also began sourcing byproducts for pet food and other markets in 2020, increasing the valuation and utilization of the regenerative livestock, and helping bring additional revenue back to farmers and ranchers.

As a result of the growing market demand and our expanded supply partnerships, OHP was able to increase payments back to farmers and ranchers fulfill our specific public benefit purpose. In 2020, OHP paid partnering regenerative farmers and ranchers over \$69,000 in direct premiums for the value of their regenerative production and the farm/ranch traceability.

OHP did not encounter any circumstances that hindered achieving our specific public benefit purpose in 2020.
