IMPACT

At the end of 2020, we had 15 organizations actively using BackpackEMR across 20 countries. These clinicians have recorded 42,000 patients and logged over 75,000 visits with a 44% return visit rate. Ongoing healthcare for these individuals will be improved with access to past medical histories and the ability for clinicians to track referrals and follow-ups needed. Additionally this information will be collated with other health data tracking to better distribute limited medical supplies.






ADJUSTMENT TO COVID-19

The pandemic slowed down both foreign and local traveling medical teams serving rural communities. Our team switched focus to provide virtual care for these communities, building out a new web portal for remote doctors to review patient charts that were captured while offline. This will bring the care directly to these communities while travel is restricted, but can also help to shift focus away from medical professionals traveling in person, but rather giving feedback remotely.

IMPACT MEASUREMENT

Ecotone Analytics created an Impact Measurement report for Binary Bridge, and we are able to show that for every \$1 invested in Binary Bridge, BackpackEMR provides \$6 of Social Return On Investment (SROI). We'll continue to measure our impact as we grow to further refine and validate those numbers.
