

SBC 2020 Annual Report

Wallflour Foods is on a mission to empower female entrepreneurs and make amazing waffles. We started Wallflour because we have always been committed to helping female entrepreneurs as individuals but realized we could make an even greater impact as female business owners. Wallflour is currently 100% female founded, owned and operated.

This is our third year sharing the progress we've made towards our mission. Decisions that support our mission in 2020 were:

- We purchase our butter from a dairy cooperative that supports female farmers.
 Rochdale Farms is a cooperative project dedicated to helping small-scale farmers and farmer cooperatives market their hand-crafted products, grow sustainably, and support local communities.
- II. We work out of a commercial kitchen that has women in leadership. The Good Acre is a non-profit commercial kitchen that has women in director positions and includes a woman as board president.
- III. We work with female designers and photographers to bring our brand to life. This year we worked with Francine Thompson -- a graphic designer and stylist based in Minneapolis -- to help create our pitch deck and other marketing materials.
- IV. We continue to participate in female-centric and supportive events. We always offer to provide free advice and mentorship to women on their business, marketing and/or entrepreneurship journey.

Year three has been an especially challenging year for our business. Covid-19 brought new manufacturing and production issues as we tried to keep people safe and out of the kitchen. The real need to create distance from others also made it harder to make more progress on our mission this year. As we've grown, our time has primarily been spent in waffle production instead of outreach and support to other female entrepreneurs. In 2021, we hope to expand our production and potentially add a new employee so that we can begin creating jobs for entrepreneurs.

We remain committed to our mission and are optimistic in what we'll be able to accomplish as our business grows.
