Significance of UR Turn, SBC

Helping more students advance along the pathway to higher education.

Ways in which UR Turn, SBC pursued its stated specific public benefit purpose from January 1, 2021 through December 31, 2021

1. Conducted outreach to disadvantaged communities in Alabama and Louisiana; secured new customers in both Alabama and Louisiana – both of which serve high numbers of students of color and low-income students.
2. UR TURN goal setting and progress-tracking software is now serving students in 4 states: Minnesota, Illinois, Alabama and Louisiana.
3. Exhibited at Career and Technical Education conferences in Alabama and Louisiana
4. Conducted considerable email and social media outreach across the nation

2. Extent to which UR Turn pursued its stated purpose to “help all students move along the pathway to post-secondary education,” the company accomplished the following activities in 2021:

1. Added new tracking feature to assist AVID coaches in high schools; AVID stands for Advancement Via Individual Determination and is a highly recognized support model for first generation college aspirants in low-income communities.
2. Provided customer support to nearly 12, 000 students, families and counselor (over 50% of students served are students of color; over 70% of students are eligible for free/reduced price lunch)

3. Circumstances that hindered efforts to pursue the specific public benefit

1. Public or face-to-face outreach remained a challenge as the COVID variants continued to interfere with the operations of schools and continued to shut down schools, conferences and other public meeting opportunities




