Corporation, Co-op, LLC, LLP los yog LP: Yog tias koj ua ntawv thov rau Minnesota, Kev Lag Luam Txawv Teb chaws, los yog Lub Tuam Txhab Non-Profit Corporation, los yog Lub Tuam Txhab a Cooperative, Lub Tuam Txhab Txhaum Cai, Limited Liability Company, Limited Liability Partnership los yog Limited Partnership, koj yuav tsum tau rov ua daim ntawv rov thov dua tshiab Annual Renewal ib xyoos ib zaug thaum puv nkaus ib xyoos, pib kiag thaum hnuv koj tau ua ntawv mus thov kev cuv npe zwm cia nrog rau lub xeev Secretary of State. Koj lub lag luam yuav yog "statutorily dissolved" (tsis lees paub tias muaj nyob rau hauv Minnesota lawm) yog tias koj tsis ua koj daim ntawv rov thov dua tshiab Annual Renewal. Koj lub lag luam yuav poob rau qhov rau tsis lees paub tias muaj lub lag luam lawm (statutorily dissolved), koj yeej rov qab thov kom siv tau lub npe dua (yog tias lub npe ntawd tseem tsis tau muaj neeg siv) es yog rov ua ntawv thov dua tshiab rau lub xyoo ntawd thiab them cov nqi ntaub ntawv.

Ntxiv rau qhov es xa cov ntaub ntawv thov dua tshiab Annual Renewal, cov tuam txhab Public Benefit Corporations mas yuav tsum kom lawv ua xa daim ntawv qhia txog cov txiaj ntsib tau txhua xyoo Annual Benefit Report ntawm ib xyoos twg ua ntej lub Plaub Hlis tim 1st, kom qhia tag nrho ntawm kaub-ob lub hlis es xaus rau lub Kaum Ob Hlis tim 31st ntawm xyoo ua ntej thiab them tus nqi ntaub ntawv yog \$35 mus rau Secretary of State.
