GLITCH is focused on solutions that directly give power, influence, and freedom to game developers, specifically those seeking to create new modes of play for emerging audiences.

This past year, we have continued our work with the Moonrise Fund and have backed the first three game studios with equity investments of \$120,000-\$250,000 USD. The Founder's Kit has expanded to include five new pitch decks from game developers worldwide and we now regularly update a living collection of tools, insights, and resources. Alongside these resources, we launched several original shows, including "Publish Me, Punish Me" and #FutureOfPlay Direct, engaging hundreds of thousands of concurrent viewers live during E3 and The Game Awards.


