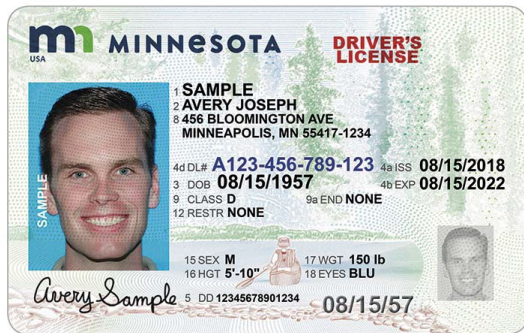



Figure 4: Sample of MN Driver's License
