# AV Hospitality SBC A Minnesota Specific Benefit Corporation Annual Public Benefit Report For The period Ending December 31, 2022

AV Hospitality SBC operates a variety of hospitality services at Apple Valley American Legion Post 1776, a Minnesota Non Profit Corporation.

Its Board of Directors and management are focused on the three specific benefits set forth in its Articles of Incorporation which are as follows:

- To operate hospitality services including a full service bar-restaurant, a community event center and a catering service providing a variety of foods and beverages from a site owned and operated by Apple Valley American Legion Post 1776, a Minnesota Non Profit Corporation (Post 1776).
- 2 To the extent possible, to purchase locally sourced foods, beverages and products and services from veteran owned and operated entities based in and actively involved in the community.
- To provide high quality jobs with living wages and benefits, a positive work environment and good working conditions for employees. When possible, granting a veteran, or the spouse of a disabled or deceased veteran, a hiring preference and training of those individuals for careers in the ever-growing hospitality industry.

The accomplishments for each specific benefit of AV Hospitality SBC during the year ending December 31, 2022 are:

#### Specific Benefit 1 Accomplishments

Efforts to achieve the first benefit began in the Spring of 2022 when AV Hospitality SBC management and staff opened the restaurant and bar within the building at 14521 Granada Drive in Apple Valley Minnesota owned by Post 1776. As the year progressed AV Hospitality SBC staff hosted special events on Memorial Day, July 4th and Veterans Day.

### Specific Benefit 2 Accomplishments

In order to achieve the second specific benefit the AV Hospitality SBC team began aggressively seeking veteran owned and operated entities to supply food and beverages.

AV Hospitality SCC has reached out to several veteran owned businesses to evaluate the feasibility of a customer/vendor relationship. Initially the team reached out to Veterans Farming Initiative, a non-profit in Montrose Minnesota to establish a supply relationship. Veterans Farming Initiative helps heal Veterans, their families, our communities, and the environment through sustainable agriculture.

Later discussions began with Warrior Brewing Company of Duluth Minnesota to become a supplier of its beers. Warrior Brewing is the culmination of two disabled veterans, determined to

produce some of the regions finest craft beer while simultaneously continuing to serve the military, veteran, and first responder programs within their community and beyond.

AV Hospitality, SBC is proceeding with onboarding of Upper Lakes Foods and La Dona Brewing, both veteran owned businesses. Deliveries will commence in the first quarter 2023.

AV Hospitality SBC is building a growing list of Veteran owned and operated vendors to become part of its supply chain.

#### Specific Benefit 3 Accomplishments

The third specific benefit requires constant efforts by the entire AV Hospitality SBC employee team to identify ways in which the work place can become one of the best places to work. Prioritizing open communication and responsive management is a commitment of the Board of Directors.

AV Hospitality SBC offers a benefits package that exceeds hospitality industry standards for similar size businesses measured in both annual sales volume and number of employees. These benefits include; health insurance, paid time off, holiday pay, Simple IRA, HAS, dental insurance, life insurance, and paid bereavement leave.

At periodic staff meetings, the employees review all of the AV Hospitality SBC public benefits in order to improve communication of those specific benefit goals to the customers of the restaurant and bar.

All employment opportunities with AV Hospitality SBC are presented with an introduction of the three specific benefits which AV Hospitality adheres to throughout the organization.
