Attachment to 2023 Annual Benefit Report

Green New Deal Homes SBC, a Minnesota Public Benefit Corporation

This report covers activities from January 1, 2022 through December 31, 2022.

The corporation engaged in multiple activities to pursue and create the public benefit of designing and building affordable zero-net carbon homes to have a scalable impact on climate change and household income stability.

The activities we undertook to pursue or create the public benefit included the following:

- We developed and launched our website, greennewdealhomes.com
- We created a design and construction documents for a simple, cost-effective 760 ft2
 zero energy one bedroom home called the Sapling
- We began design work on a smaller zero energy home design, less than 600 ft2
- Engaged with local builders and product distributors in conversation and analysis about how to achieve cost-effective high-performance residential construction. Documented this work and distributed it to industry allies.
- Developed more presentation materials to use for public and industry-related education and outreach.
- Began discussions internally and in response to inquiries about developing zero-energy strategies for retrofits to existing homes.
- Gave a presentation at Better Buildings Better Business conference in Wisconsin, hoping to introduce our work and make business connections that might lead to use of our services and products

The extent to which we believe we delivered public benefit included the following:

- Our owner participated in numerous public events, including as a panel member in a climate justice town hall webinar hosted by the Sierra Club Minnesota in January, and at an in-person forum called Responding to Climate Change at the University of Minnesota Duluth in March.
- We completed the research project "How Much and How Much Better?", in partnership
 with the University of MN Duluth Office of Sustainability, and three student interns. We
 published our results on our website. The information is meant to assist the general
 public and people in the housing industry (realtors, appraisers, and builders) to
 understand and appropriately value the benefits of zero net energy building.
- We completed our contract for the pilot curriculum and training project to the nonprofit organization Green New Deal Housing, training more than 25 people with the Laying the Groundwork for Sustainable Housing 4-part course.
- Under a new contract with Green New Deal Housing, we developed more coursework
 and delivered extensive classroom training and field studies in green construction to a
 cohort of workforce trainees, many of whom come from marginalized populations.

- The nonprofit Green New Deal Housing began construction on their first zero energy home, in a low-income neighborhood, using our Evergreen House design.
- Wrote an article for a local newspaper making the case for zero energy homes in our climate.
- Spoke at the Upper Midwest Building Performance Association conference in Minneapolis about the Green New Deal Housing workforce training program in green construction, to aid others' efforts toward similar programs.

Circumstances that hindered efforts to pursue and/or create the public benefit included the following:

- Submitted a grant proposal to Launch Minnesota for funding to assist the development of more designs and our organizational growth, but were not awarded funding.
- Construction and housing costs in the region remained at an all-time high, resulting in loss of potential projects (and revenue) from numerous leads we had from people interested in building zero energy homes.
- We determined that the similarity in our company name (Green New Deal Homes SBC) with the nonprofit organization we support with some of our work (Green New Deal Housing) hindered our ability to be recognized as a corporation in our own right. We closed the year with the idea that we might rename the company.

Post script: On February 7, 2023 our company voted to rename itself Just Housing SBC. The company also revamped its stated public benefit to better articulate and align with its mission and goals, as follows:

The specific public benefit purpose of the corporation is to enable and accelerate equitable and widespread adoption of sustainable solutions for housing; and remove barriers to individual and community needs for healthy, affordable, durable homes built to operate without burning fossil fuels.
