## **Environmental Solutions**

Ten Thirty Environmental Solutions, SBC is a Specific Benefit Corporation. Ten Thirty Environmental Solutions, SBC's goal is to positively impact public health and the environment by providing environmental solutions to customers that put public health and the environment first in any solution offered. In addition to the goal of protecting public health and the environment Ten Thirty Environmental Solutions, SBC seeks to serve those people in Minnesota and around the world who are impacted by homelessness, poverty, a lack of access to items and/or services to meet their basic needs, as well as those who are living without the hope of Jesus in their lives.

During the calendar year 2022 Ten Thirty Environmental Solutions, SBC helped address the issue of homelessness in the Minneapolis/St. Paul metro area by giving a portion of its revenue and 10% of its annual profits to local nonprofits that are working to end homelessness in the community. This totaled over \$8,500 in donations to help address poverty/homelessness in the community in Minnesota. In addition over \$37,000 was donated to ministries helping share the hope of Jesus with people in our community and around the world. On top of the financial resources given to support these efforts Ten Thirty Environmental Solutions personnel donated over 200 hours of time to these efforts over the calendar year 2022.

In addition to helping fight homelessness Ten Thirty Environmental Solutions, SBC also designed 89 new septic systems around the Minneapolis/St. Paul metro area to help properly treat wastewater and protect public health and the environment. In addition to the design of new septic systems Ten Thirty Environmental Solutions also inspected 16 existing septic systems in the Minneapolis/St. Paul metro area to ensure they are protective of public health and the environment.

Ten Thirty Environmental Solutions is looking forward to 2023 and continuing to help in the effort to address homelessness and hopelessness in our community and around the world as well as helping to protect public health and the environment across the State of Minnesota.
