For the year 2022, Hoyo, SBC continued its stated mission of the empowerment of single mothers in the Somali community. This is being accomplished by hiring Somali mothers for a position that utilizes their existing skills in making Sambusa and traditional Somali sauces. Through employment these mothers are paid a livable wage for their contribution. We are also providing transportation to and from work for some employees and taking other steps to reduce existing barriers to gainful employment.

Beyond this, Hoyo, SBC is teaching skills needed in the American workforce, that with these skills and a history of employment these mothers are equipped to move forward in gainful employment in other industries. Ideally, we would empower these mothers to launch their own business.
