# Showcraft GBC Minnesota Annual Benefit Report 2022

#### **Overview & Third-Party Standard**

In 2022, Showcraft GBC (which acquired Showcraft, Inc. in 2021) celebrated its 26th anniversary as a leading trade show exhibit producer serving clients across multiple industries with the stated purpose of empowering human connection.

Showcraft GBC's leadership has selected the B Impact Assessment (BIA) as its third-party standard for benefit reports. Used by more than 100,000 businesses worldwide, the BIA remains the most widely used impact measurement and management tool for businesses to measure, compare, and improve their social and environmental impacts. The BIA is governed by the non-profit organization B Lab and meets the statutory requirement that the third-party standard must be comprehensive, credible, transparent, and independent.
