Living Ark SBC has continued to serve our specific benefit of supporting drug and alcohol recovery. In 2024, our actions included operation of a Sober House under the policies and guidance of the Minnesota Association of Sober Homes, of which we are a member. We have extended beyond those requirements by providing free transportation on multiple occasions to enable house residents to attend AA / NA meetings. We have held sober holiday events at Easter, Thanksgiving, and Christmas including meals at the expense of the business. We also held free sober picnic events that extended to recovering alcoholics beyond our residents. We donated \$300 to the Elk River ALANO (AA). We purchased nicotine gum and mints for a recovering alcoholics who also want to overcome cigarette addiction. We hold regular meetings at the house with the residents to discuss recovery in a variety of unique ways, supplementing the AA / NA approach with alternative personal conversations about history and goals, life circumstances, gratitude, and advice from multiple recovery publications. The business also provides a bookshelf of recovery resources and has added to the bookshelf this year.
