Highlights of the Year

One of our biggest highlights of 2023 involved a brand new mobile mini golf course which participated in the Minnesota State Fair. A local artist, Jason Arney-ONEil, designed and created several of the holes for this course.

We also hosted several Art Pop Ups in 2023, inviting local artists to set up in our space to sell and showcase their work to the public.

In addition to supporting local artists, we also showcased several new performers on both of our stages last year, including Creative Arts Secondary School Student Band, Ice Climbers, The Strum Brothers, DJ the DJ, and Joy Trip Band.

To add even more to our space, we commissioned several new art pieces, including a custom made 20 foot stained glass mural created by a local artist Karl Unnasch.

With regard to the period covered by this report, January 1st 2022 to December 31st 2022, Can Can Wonderland, SBC pursued the specific benefit purpose stated in its articles in the following ways:

2023 was a fantastic year for us. We hired a new Programming Manager, Regina Bailey, who really took us to the next level with the variety of talent and events she booked. She made use of both our stages, as well as daytime events, to give as much support as possible to new artists and performers, while maintaining supportive relationships with our current artists.
