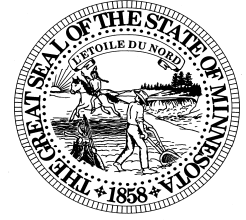

## INSTRUCTIONS

The UCC and Tax Lien Initial Dataset file will be provided in an Excel spreadsheet in a single file. The file will be in a comma-delimited format (CSV). Each field will be encapsulated with double quotes regardless of the datatype.

An email notification will be sent to the email address listed on the request form. The email will include a link to the Initial Dataset file. You will view this information in your "Download Inventory" located in the Minnesota Business and Lien System (MBLS).

To obtain updates for data and/or images you will need to register online at [mblsportal.sos.mn.gov](https://mblsportal.sos.mn.gov) and purchase weekly subscriptions. Weekly subscriptions for data and/or images will be each week. Note: Image purchase is not available for Tax Liens.

To order the UCC Financing Statement and Tax Lien database you must sign the UCC Database License Agreement. The License Agreement can be obtained online at [mblsportal.sos.mn.gov](https://mblsportal.sos.mn.gov).
