History of Apex Efficiency Solutions

Apex Efficiency Solutions was founded in 2012 as a result of our ownership team growing tired of the way Energy Service Companies delivered renewable energy and energy efficiency projects. Our new business model has changed the way our projects are developed, marketed, and delivered.

Apex Efficiency Solutions was incorporated as a Minnesota Public Benefit Corporation on January 2, 2015.

Apex's goal is to improve the environment by upgrading the energy efficiency of buildings, reducing both the carbon emissions and pollution that is released to the environment from these facilities. The company also serves the less fortunate by helping alleviate poverty, improving educational opportunities, providing housing and addressing the exploitation of children.

Pursuit of our Mission

Regarding the period covered by this report, January 1, 2017 to December 31, 2017, Apex Efficiency Solutions pursued the specific benefit purpose stated in its articles of incorporation in the following ways.

Apex Efficiency Solutions works with commercial and industrial clients to improve their energy efficiency. We do that by identifying potential energy saving opportunities, and then working with them to quantify the costs and savings associated with those opportunities, ultimately implementing them and then providing measurement and verification of the actual savings achieved.

We believe that Apex Efficiency Solutions was successful in achieving the goals of our specific benefit purpose in the following ways.

In the projects completed with our clients in 2017, we will save them an estimated 4,325,371 kWh of electricity. These projects were completed at various times throughout the year. When we add those projects to the past projects our company has completed for our clients, the total energy savings are an estimated 10,623,388 kWh of electricity. According to the EPA, this equates to over 7,906 metric tons of CO2 reduction. Additionally, in the projects completed with our clients in 2017, we will also be able to save them an estimated 48,917 kWh in renewable energy (Solar). According to the EPA, this equates to an additional 36.4 metric tons of CO2 reduction.

Apex Foundation:

As one of the first Specific Benefit Corporations in Minnesota, we strive to alleviate poverty and homelessness, as well as improve education opportunities and address the exploitation of children. We tithe corporate profits into the Apex Foundation to assist with this mission.

It is our goal at Apex to continuously improve the world through the implementation of fiscally-responsible and environmentally-friendly projects. Plus, we actively work to improve the community

around us and abroad by dedicating a portion of each year's profits to these causes. Half of Apex Foundation's assets are used to help in the local community. The other half of the assets are used globally to help fight poverty and injustice.

In 2017, Apex had sent 18 people on trips to work in Haiti. Each person worked in the community of Williamson for one week. In January 2017, we sent 12 people to Haiti to Survey land for a sewing building and bakery, excavate a ravine and install drainage culverts by the medical clinic, finalized drawings for the clinic and the "abandoned kids home" that will be complete in 2018. Of those on the trip, 10 people hiked up to a remote Mountain village, Nikola, to meet with the Pastor and head teacher at the village's schoolhouse. Apex employees wanted to offer financial support to help where they needed it the most. It was decided that our help was desperately needed to close the gap in the teachers' pay. Many of the teachers had already left due to lack of pay, our support would mean keeping quality teachers employed so the children can have a great education. Additionally, 4 people on this trip rewired electrical lines in five residences homes in a town called Archaea. Clothing measurements were also taken for Pastor Joissant's 5 children and the 10 abandoned children he has taken into his Williamson home over the last few years. These measurements would be used at Grace Lutheran Church for a clothing drive for the family.

In February 2017, one individual went to Haiti to work in Williamson for one week. While there this individual helped to start on the digging/drilling of a second well for the community. It is located right down the road from the school and will soon be used to supply fresh water at the school, as well as for the community members.

In June 2017, 2 individuals went to Haiti to work in Williamson. One person was there for one week, the other stayed for two weeks. While on this trip, the main project was the installation of solar panels at three local Haitians residences, as well as at the guest house where all World Wide Village's teams stay on their trips. In addition to the solar panels, they also met with the Pastor and teachers from Nikola, the Mountain Village that Apex employees are sponsoring. This was to discuss how things were going since our January visit, and to see what additional needs they may like our assistance with.
