

MNstarter, SBC was incorporated on September 8, 2016 as a Specific Benefit Corporation under Minnesota's Public Benefit Corporation Act (the "Act"). Pursuant to Section 304A.101 of the Act, specific public benefit purpose as stated in it's Articles of Incorporation is to pursue the specific public benefit purposes of enabling equity crowdfunding campaigns for Minnesota businesses and helping Minnesota residents make informed choices about capital investment.

With regard to the period covered by this report, January 1, 2017 to December 31, 2017, MNstarter, SBC pursued the specific public benefit purpose stated in its articles of incorporation

- Secured 1-year contract to execute on a USDA funded initiative with Region Five 1. Development Commission (R5DC) to:
 - provide crowdfunding portal technology
 - host up to 3 crowdfunding campaigns
