2018 Specific Benefit Corporation Actions in 2018 Supporting the Specific Benefit For Living Ark SBC

- 1. Article V of Living Ark SBC lists a variety of means of providing the public benefit of helping the recovering alcoholic and/or addict community. All of the items listed below are in alignment with Living Ark SBC Article V.
- 2. 2018 is the first year of operation for Living Ark SBC. Living Ark SBC operated at a loss in 2018. Because there was no corporate profit, there were no donations in 2018 other than in-kind contributions described below.
- 3. Living Ark opened a men's sober house in Otsego Minnesota, per Article V, and operates a program of recovery there with rules prohibiting use of alcohol or drugs, or possession of drug-related paraphernalia. The program does not include any treatment, per se, but rather a sober community and an environment conducive to recovery.
- 4. In addition to program members (residents) who had funds for the program deposit and monthly dues, the Living Ark SBC sober house took in four homeless alcoholics/addicts with no money and no job. All four obtained jobs. Two remain into 2019, and two left the house in 2018 without paying anything for their stay, and Living Ark SBC has not made and will not make any attempt to have them pay for their stay.
- 5. Living Ark SBC provided bicycles for transportation for members without a car or driver's license, and assistance in finding employment. Living Ark SBC provided chauffered car transportation on various occasions for medical care, application for a driver's license, Alcoholics Anonymous / Narcotics Anonymous meeting attendance, and other such quality of life needs, at no expense to members.
- 6. Living Ark SBC established a "living skills" program to teach some residents to make beds, do laundry, dress and groom for job interviews, and cook by recipe, as needed and appropriate.
- 7. The owner of Living Ark SBC performed all duties to set up the house and provide services to the residents for zero salary.
