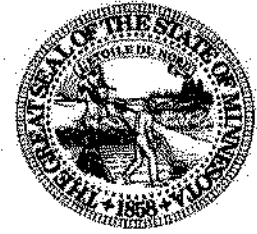



HISTORY OF APEX

Apex Facility Solutions was founded in 2012 as a result of our ownership team growing tired of the way Energy Service Companies delivered renewable energy and energy efficiency projects. Our new business model has changed the way our projects are developed, marketed, and delivered.

Apex Facility Solutions was incorporated as a Minnesota Public Benefit Corporation on January 2, 2015.

Apex's goal is to improve the environment by upgrading the energy efficiency of buildings, reducing both the carbon emissions and pollution that is released to the environment from these facilities. The company also serves the less fortunate by helping alleviate poverty, improving educational opportunities, providing housing and addressing the exploitation of children.

PURSUIT OF OUR MISSION

With regard to the period covered by this report, January 1, 2020 to December 31, 2020, Apex Facility Solutions pursued the specific benefit purpose stated in its articles of incorporation in the following ways.

Apex Facility Solutions worked with a number of school districts and municipalities to help them operate more efficiently. Education facilities have the unique challenge of dealing with many students, staff and activities, as well as maintaining several buildings, some of which may be spread apart by several miles. Apex aims to help keep education facilities organized so everyone can do their jobs efficiently, as well as keep the buildings running efficiently and on budget. In the municipality sector, our programs can be a great way to address deferred maintenance, improve service to residents, increase energy efficiency and implement renewable energy solutions.

We believe that Apex Facility Solutions was successful in achieving the goals of our specific benefit purpose in the following ways.

In the projects completed with our clients in 2020, we will save them an estimated 7,643,438 kWh of electricity, annually. These projects were completed at various times throughout the year. When we add those projects to the past projects our company has completed for our clients, the total energy savings are an estimated 18,967,845 kWh of electricity. According to the EPA, this equates to over 13,411 metric tons of CO2 reduction. This is equivalent to 2,897 passenger vehicles driven for one year!

Additionally, in the projects completed with our clients in 2020, we will also be able to save them an estimated 1,412,300 kWh in renewable energy (Solar). According to the EPA, this equates to an additional 999 metric tons of CO2 reduction, which is equivalent to an additional 216 passenger vehicles driven for one year!

As one of the first Specific Benefit Corporations in Minnesota, we strive to alleviate poverty and homelessness, as well as improve education opportunities and address the exploitation of children. We tithe corporate profits into the Apex Foundation to assist with this mission.

APEX FOUNDATION

It is our goal at Apex to continuously improve the world through the implementation of fiscally-responsible and environmentally-friendly projects. Plus, we actively work to improve the community around us and abroad by dedicating a portion of each year's profits to these causes. Half of Apex Foundation's assets are used to help in the local community. The other half of the assets are used globally to help fight poverty and injustice.


In 2020, Apex donated \$500.00 to nine local nonprofits in and around the twin cities. On top of the monetary donations Apex employees enjoy getting hands-on with the non-profits that we support and partner with. Unfortunately due to Covid and the restrictions that have been imposed on numerous businesses and organizations, our employees were not able to volunteer their time with our partner organizations in 2020.

Also due to Covid, and International travel restrictions, we were unable to complete our company paid trip to Haiti, where we partner with World Wide Village and serve alongside our Haitian brothers and sisters. While there we teach job skills, help construct homes, develop and plan agricultural and business programs, lead children's programs and build lasting relationships with the people and communities where we serve.

Apex did donate \$1,405 to WWV in 2020 to help a small village school in the mountains that our company has committed to supporting. This donation was on top of the monthly recurring donations that our employees have decided to donate out of their pockets.
