

Showcraft GBC Minnesota Annual Benefit Report 2021

Overview & Third-Party Standard

Showcraft GBC acquired Showcraft, Inc. on October 1, 2021. For more than 25 years, Showcraft has been a leading trade show exhibit producer serving clients across multiple industries to help them showcase what's remarkable about their products and services.

Showcraft GBC and its Board of Directors have selected the B Impact Assessment (BIA) as its third-party standard for benefit reports. Used by more than 100,000 businesses worldwide, the BIA remains the most widely-used impact measurement and management tool for businesses to measure, compare, and improve their social and environmental impacts. The BIA is governed by the non-profit organization, B Lab, and meets the statutory requirement that the third-party standard must be comprehensive, credible, transparent, and independent. Benefit corporation statutes require a benefit report to include narrative responses to a specific set of questions. Below are our responses to those statutory questions.

Describe the ways in which the benefit corporation pursued general public benefit during the year and the extent to which general public benefit was created.

Showcraft GBC's mission is to be the leading events partner for world-changing companies. Since acquiring Showcraft, Inc., on October 1, 2021, Showcraft GBC has taken meaningful steps to align with the BIA on matters of Governance, Workers, and Community. We anticipate taking further steps in these areas as well as addressing the matters within the BIA of Customers and the Environment as we pursue B Corp certification in 2022, Showcraft GBC's first full calendar year of operations.

Governance

- Created and implemented a company mission statement
- Created and rolled out an employee handbook with ethics and whistleblower policies
- Incorporated social and environmental impact into our decision-making processes
- Created and defined an organizational chart with clear job descriptions for employees
- Significantly improved the company's financial reporting mechanisms for regular review

Workers

- Improved employee pay; 100% of our workers earn at least a living wage
- Improved employee retirement benefits and expanded benefits to all employees
- Expanded healthcare and dental benefits to all employees
- Implemented monitoring and evaluation tools to measure employee engagement
- Implemented an unlimited PTO policy for all employees

Community

- Reconfigured and installed a gender-neutral bathroom in our offices
- Expanded the diversity of our company's management team; 67%+ identify as women

Describe any circumstances that hindered efforts to pursue or create general public benefit.

The ongoing COVID-19 pandemic has limited our ability to engage in normal business operations as sporadic event cancellations remain a key issue for our company. However, we remain on track to continue building on our initial delivery of public benefit from the last 3 months of 2021 after completing the acquisition of Showcraft, Inc., in 2022, Showcraft GBC's first full calendar year of operations.
