Via Vita, SBC is a specific benefit corporation that has elected to develop a web application and related programs that will guide teenagers and young adults by helping them navigate the difficult path to careers that are rewarding and meaningful. The corporation began development of the software in 2019 and completed most of the development by April of 2020. Upon completion of the development phase, the software was put through a testing phase by more than 100 students in 2020. The 2020 testing led us to conclude that we do further testing in 2021 with organizations such as schools and other consulting organizations who help the targeted younger generation with these life journey decisions. The accumulated learning from this and ongoing testing we believe will soon help us determine appropriate enhancements that will be needed for the young adults, as well as additional capability for those organizations and individuals who guide them through these life decisions.

We hope to make these platform changes in 2022 as we are gaining clarity and understanding of viable sustainable customers and delivery systems in order to help these young people.
