

#### Highlights of the Year

We were able to reopen at the end of March 2021 to the public after many months of being shut down. We welcomed many staff, artists, and guests back to our business. The main focus for us in 2021 was expanding a brand new retail and gift shop area for many local artists to sell their products and get exposure. The gift shop opened in the fall of 2021 and has been a great success. Once restrictions were fully lifted we were also able to book live entertainment again, and saw the return of Queer Circus, Silly Miss Tilly, Comedy Night, Amazing Scott, Vivid Black Paint, and many more!

With regard to the period covered by this report, January 1st 2021 to December 31st 2021, Can Can Wonderland, SBC pursued the specific benefit purpose stated in its articles in the following ways:

Using our platform and our brand to bring attention to local artists. Showcasing to the public immersive and entertaining art installations and hosting countless creative events. The new retail area has allowed many artists to gain exposure and sell their various art pieces inside Can Can Wonderland. Despite having to operate with government mandated restrictions, Can Can Wonderland paid out \$63,026.59 to entertainers, artists, fabricators, and performance artists during the year of 2021.

The following is a description of how we believe we succeeded in achieving the goals of our specific benefit purpose:

With our reopening we were able to reach out to many artists and offer them support once again. With the opening of our gift shop we were able to extend our reach of support to many new artists we have not worked with previously.

# The following is a description of what prevented us from achieving the specific benefit purpose stated in our articles:

Due to a government mandated shutdown, Can Can Wonderland did not reopen to the public until the end of March 2021. We were unable to operate at full capacity until May of 2021. Keeping safety as the top priority, we thought it would be best to gradually introduce programming and live entertainment to the public once again. Sadly we had to cancel our New Years Eve Party which included performances by Queer Circus, Amazing Scott, Fly Freak Studio, and many others due to a voluntary shut down in response to many stuff members testing positive for Covid-19.
